2. TAILORED SCHEDULE OF DESIGN & ADVISORY SERVICES

2.1 Design & Advisory Service

To suit modern procurement processes, Notts Sport[®] have created a flexible range of services to provide advice, management and action during the development, procurement and delivery stages.

Our surfacing product portfolio includes wide ranging synthetic grass options including the Notts Sport[®] banded product family and a high quality selection of synthetic grasses from sand-filled to sand-dressed, 3rd generation and non-filled, including tufted and woven manufactured textiles; from the specialist manufacturing sector.

In design terms, a Notts Sport[®] solution is ideal for customers who wish to retain control of facility characteristics and accurately specify products and components within tender documentation. We offer a wide range of surfacing solutions to satisfy different customer needs, sporting purposes and environmental positioning. To ensure a holistic project package, we also provide design services for perimeter fencing and floodlighting, equipment and associated features.

3. NOTTS SPORT® INCOME ROUTE

3.1 Nominated supplier method:

With this unique approach, Notts Sport[®] make a return by supplying the proposed synthetic components at the point of construction and our return is therefore part of the contract sum.

Should we be appointed on this basis and the project does not go ahead then we will still not charge a fee for works completed, it is entirely at risk.

Only when customers use our development work and/or specification and proceed to tender the project without our involvement will we issue an invoice for our time & work (as per item 2 & 7 in the terms & conditions) calculated against current rates for specialist synthetic pitch consultants.

- We will collect income by supplying the specialist textile component products (e.g. synthetic grass) to the appointed contractor <u>at the point of construction</u>.
- The Design & Advisory Services described are available to you at no additional fee to Notts Sport[®] supplying the chosen synthetic components. Please select the suite of services you require to ensure your project is completed successfully.
- This product 'brokerage' system is suitable for customers who enjoy purchasing freedom.
- Maximise construction budget Minimise development costs.
- Reduce up-front costs if the absolute completion of the project is in any doubt.
- Exclusive service to nominated supplier method: quality control of your synthetic components during manufacture and transportation.

3.2 Notts Sport[®] Benefits

It should be noted that Notts Sport[®] are not directly associated with any contractors and as such stand independent of any contracting organisations that may be awarded the contract for the pitch development. Therefore, we represent the client team and offer non-contractor led advice, unlike many contractors who offer management services in house.

We believe that by extending the role of supplier to include the project management of the entire scheme, we offer reassurance to our customers that what is specified within the tender will be completed to the highest standards on site. Our network of contractors are also aware that as we put them forward for tenders appropriate to their organisation, they would be taken off future tender lists in the event of poor performance or service.

This continual assessment of our projects means that customers have the comfort that only contractors consistently providing high quality facilities will have the opportunity to tender for the scheme as Notts Sport do not want their surfacing to be associated with poorly run, built and delivered facilities.

Through our traditional procurement route, tenders are completed on a lump sum basis and therefore, contractors are bound by the contract sum they submit against our specification. We include a 5% contingency to cover any unforeseen circumstances, but aside from this, we believe it offers customers reassurance that contractors are not in a position to make additional claims for works and increase the contract value whilst the build is being completed.

Our role as project manager during construction means that any claims for additional works are only approved on the instruction of Notts Sport with the agreement of the client, again offering reassurance that only valid claims would be recommended to the client.

Additionally, we do not have a sole supplier of synthetic materials and therefore do not offer customers a standard range of products. We work with synthetic grass manufacturers to ensure that we offer as wide a range of synthetic solutions for every project, giving further reassurance that the chosen design is bespoke and determined against each individual client requirements.

We believe that our service offers customers the opportunity to include specialist design & project management services throughout the duration of the scheme, but without incurring expensive development costs in early stages. Throughout the project, our service is designed to offer comfort & reassurance to customers that the sports pitch they receive at the end of the project will be delivered on budget, on time and to their individual & any identified requirements and standards.

3.4 Terms and conditions of Design & Advisory Services

- 1. These terms and conditions shall apply to the agreement between us in respect of the Services. Except to the extent that these terms and conditions are varied by us in writing they shall constitute the entire agreement between us and shall prevail over your own terms and conditions.
- 2. The Services are provided exclusively in respect of Notts Sport® pitches and products installed by us or our authorised distributors (Projects). You may not use our Services in respect of any third party pitches, products or installations.
- 3. Subject to the installation of our products in accordance with our designs and advice, we warrant that the Services shall be provided with reasonable skill and care. No other warranty or guarantee whether implied by law or otherwise is given. Where the Services extend beyond advice relating to [the design, materials, specification, and functionality of artificial sports surfaces] such advice is given only on the basis of our experience in respect of projects similar to the Project, and we claim no specialist or technical expertise.
- 4. We shall have no liability to you for any loss, damage, costs, expenses or other claims arising from information supplied by you to us.
- 5. Except in respect of death or personal injury caused by our negligence, we shall not be liable to you for any loss of profit or any indirect or consequential loss, damage, costs or expenses which arise out of, or in connection with, the provision of Services by us to you.
- 6. Except in respect of death or personal injury caused by our negligence, our entire liability to you shall not exceed £1,000,000 which is the level of our Professional Indemnity Insurance at the date of this Agreement.
- 7. We shall at all times retain copyright and all other intellectual property rights in respect of any and all the documents we provide on your (or any other party's) behalf. You shall not reproduce or use these documents or drawings without our written consent, which we shall not unreasonably withhold, but for which we may require a reasonable fee. You shall keep any such documents and drawings confidential, and on termination of this Agreement (by whatever reason), you shall at our request return them and any copies (whether authorised or not) to us immediately. You shall also ensure that any other relevant party who or which has come into possession of the documents, or any copies (whether authorised or not), returns them to us immediately.
- 8. You shall, during the agreement between us, provide our employees agents and sub-contractors with such access to the Project site, and to your information and records, as is necessary to allow us properly to carry out our work. You shall make available appropriate personnel to liaise with us. You shall also advise us of rules and regulations that are in force for the conduct of personnel at the Project site, and any other relevant location, and we shall ensure that our employees, agents and sub-contractors shall comply with these.
- 9. You shall ensure that you have adequate public liability insurance for the Project site before any of our employees, agents or sub-contractors enter the site. This insurance must cover any injury suffered by our employees, agents or sub-contractors whilst on the site. You shall also ensure that before the Project commences, all relevant planning permissions, consents and other regulatory permissions are complied with.
- 10. We shall not be liable to you, or deemed to be in breach of this Agreement for any delay in performing, or failure to perform, any of our obligations if that delay or failure is due to any cause beyond our reasonable control.
- 11. Any notice to be given by either of us to the other shall be in writing, and be posted first class to the other's registered office or principal place of business. Any such notice shall be effective on the third day after posting.
- 12. No waiver by us of any breach of any provision in these terms and conditions shall be considered as a waiver of any subsequent breach of the same, or any other, provision(s).
- 13. If any provision in these terms and conditions is held by any competent authority to be invalid or unenforceable, in whole or in part, the validity of the other provisions, and the remainder of the provision in question, shall not be affected. These terms and conditions shall be governed by English Law.

4. NOTTS SPORT® FAST TRACK FUNDING

In addition to our existing Design & Advisory Service, Notts Sport are now able to extend to include the full funding of your facility all still at no up front cost or fee via our Fast Track Funding initiative.

Through Fast Track Funding, Notts Sport will work with our customers in our existing manner with the additional benefit of providing the funding for your project.

On completion, our customer would pay for the pitch over a period of 5 - 7 years with payments scheduled at either monthly, quarterly or yearly payments to suit individual requirements.

Post completion Notts Sport will arrange for all the required specialist maintenance to be completed throughout the repayment period to ensure that the pitch is kept to the optimum condition throughout its life. In addition, Notts Sport will complete annual condition surveys and performance testing throughout the repayment period to ensure that the pitch is kept to the optimum condition throughout its life.

Working on current projections we anticipate that 20 - 30 hours of external bookings would generate enough income to cover or at least go a long way to covering the cost of the pitch through the funding period. This is based on new build schemes where no funding is available so on the basis you may have monies towards the project cost, or be looking at a resurface scheme, it is likely the income would outweigh the payments.

The benefit is at the end of the 5 or 7 period the customer can take ownership of the facility and can use the entire sum generated thereafter to benefit other areas and of course, to plan prudentially for any resurfacing scheme required later in the facility life. Even if the pitch isn't let out then the benefit of being able to pay over a period of time rather than a large lump sum means that some careful financial planning will allow a fantastic new facility to be built for your specific use.

We believe that this unique approach means that with Notts Sport, you can deliver a scheme specific for their requirements leaving you fully in control of the design without having to apply for funding which is extremely difficult to secure.

At every stage Notts Sport are on hand to ensure your project goals are met and as we only make a return on supplying the synthetic components, we don't charge for our development & design services meaning that even if the scheme doesn't achieve planning or go ahead for any reason the customer hasn't incurred any expensive fees.
